### THE WORK-FAMILY CONNECTION COLLEGE SCHOLARSHIPS AVAILABLE TO QUALIFYING HIGH SCHOOL STUDENTS

**Eligibility:** High school students who are attending an accredited college or technical school in 2020 and who have attended The Work-Family Connection (WFC) programs during their elementary and/or middle school years. Attendance in any of our programs (before, after school, kindergarten wrap-around, Wiz Kids, ACE, WFC Clubs, and Summer Camps) qualifies.

**Scholarship Awards:** Up to \$2,000. Checks will be sent to the educational institution directly.

**Guidelines:** Applications must be complete and signed. Essay must be attached in no more than one page, single spaced, in size 12 Times New Roman font. Applications not fulfilling these guidelines will be not be considered.

**Deadlines and Submission:** Deadline to submit an application is **May 1, 2020 by 11:59pm** without exception. Submissions must be electronic only to [wfc scholarships@theworkfamilyconnection.org](mailto:wfc scholarships@theworkfamilyconnection.org). WFC's decisions will be made within a month and given to your high school Guidance Counselor.

**Decision Qualifications:** The decision on who receives scholarships will be at the sole discretion of WFC. There is no dispute or appeal process. Longevity with WFC and essay responses for how WFC attributed to your college/career decisions will be contributing factors in the decision-making process.

**Distribution of Applications:** Mostly through the high school Guidance Counselors. Distributions in both electronic and paper publications are possible.

**Public Announcement:** Recipients of the scholarships and their essays will be made public at Board of Education meetings, newspapers, social media, and other public forums. Photos will be taken with the recipients and these photos will be used in the announcements.
